Dr Ulpee Darbar Consultant in Restorative Dentistry, Director of Dental Education and Honorary Associate Professor BDS, MSc, FDS(Rest Dent)RCS, FHEA, Pg Cert

Ulpee is a Consultant in Restorative Dentistry and a Specialist in Periodontology at the Eastman Dental Hospital & Institute, UK. She maintains a busy clinical practice with a key interest in managing complex patients requiring an integrated approach with soft and hard tissue augmentation around teeth and implants. As a key opinion leader in soft tissue enhancement, Ulpee lectures regularly on this topic both nationally and internationally.

Ulpee is passionate about education and has been awarded medals for her skills in this area. She teaches extensively, underpinning her clinical work with training renowned for stimulating deeper thinking. She has pioneered numerous innovative learning initiatives and runs successful courses on soft tissue augmentation, among others. Ulpee has published numerous papers, written books on dental implants and recently authored a series on soft tissue grafting.

In this lecture, Ulpee will share her wealth of knowledge and expertise in soft tissue grafting around teeth and implants.

loana graduated with honours from the University of Modena and Reggio Emilia (Italy) in 2007. She practices at her private Dental Studios ID in Ravenna and Russi (RA), where she specializes in Fixed Prosthodontics, Periodontology, and Implantology.

A founding member of SIPRO (Italian Society of Dental Prosthesis and Oral Rehabilitation) and an active member of IAED (Italian Academy of Aesthetic Dentistry), she won the 1st Prize in the IAED Young Challenge 2021. She is a member of the Italian Academy of Aesthetic Dentistry, Society of Digital Dentistry, Italian Academy of Osseointegration IAO, Leading Ladies in Dentistry LLD.

A speaker and founder of her own course on Digital Dentistry: "How to maximize the potential of digitalization in Modern Dentistry" - February/June 2023. In March 2024, the second edition of this course also started, with the same innovative format that involved the aso - dental technician team as well. She has also been a clinical tutor for the implant surgery training course in Portugal. She conducted an implant training course in Italy, Kuala Lumpur (Malaysia), China, Taiwan, Vietnam focused on implant planning, surgical procedures, crestal sinus lift approach, guided implant surgery procedure.

Andrew is dual qualified in Dentistry and Medicine. He has over 33 years' experience as a clinician within the NHS, with a varied career in education, management, and healthcare leadership. Andrew has broad experience within postgraduate training, with particular interest in the quality assurance of educational programmes, widening participation and leadership development. His personal interest is service planning within rural settings, which was recognised with a Visiting Professorship to the University of Chester. Andrew also holds a Visiting Professorship in Healthcare at Coventry University.
