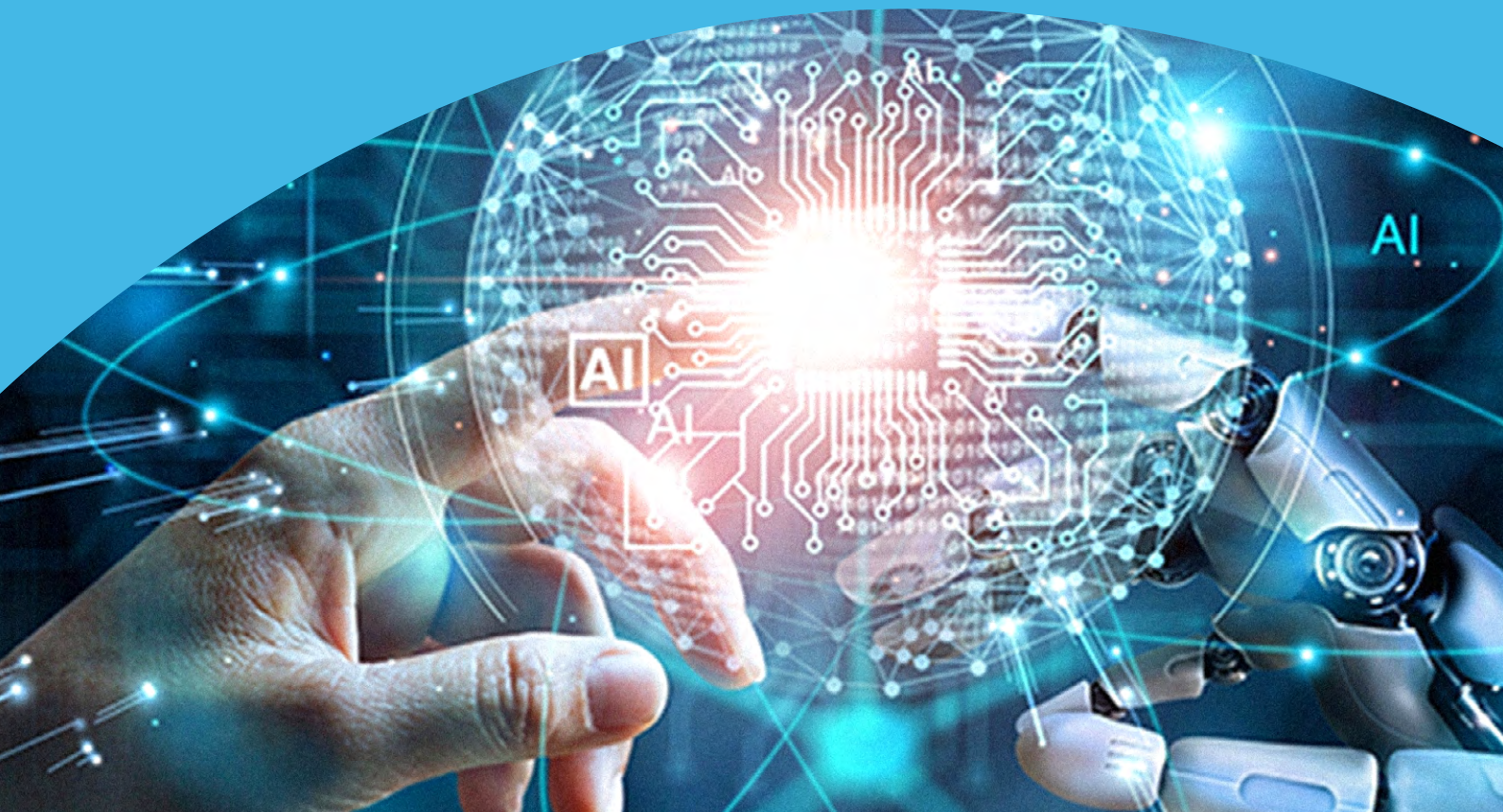

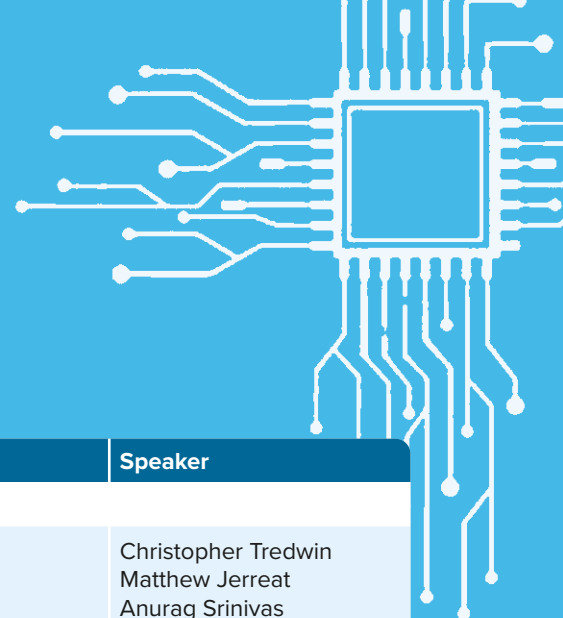

# Speakers



## Jason Wong MBE

Jason was appointed as Chief Dental Officer England in May 2024 and before that as interim Chief Dental Officer in July 2023. Jason joined the Office of the Chief Dental Officer as Deputy Chief Dental Officer in July 2020.

Awarded an MBE for services to dentistry and oral health in the new year's honours list 2020, Jason has previously chaired local dental networks across parts of the Midlands and the East of England and was also secretary of Lincolnshire Local Dental committee for 16 years. His role as Chief Dental Officer now sees him working in collaboration with local and regional teams to deliver improved outcomes for patients, while also championing the role of dentists and dentistry within the health system.

The Office of the Chief Dental Officer England represents the head of the dental profession in England, providing system wide professional and clinical leadership, by setting the strategic vision for England's oral health.

Jason is currently a practicing general dental practitioner and partner at the Maltings Dental Practice in Grantham, clinical ambassador for the mouth cancer foundation and is a well-known speaker nationally on clinical and non-clinical topics.



## Claire Forbes-Haley

After qualifying at Bristol Dental Hospital, Claire worked in general practice in Somerset. She then spent two years in hospital specialties including oral surgery, oral medicine, and paediatrics. From 2010-2014 she trained in the Hospital as a specialist in Restorative Dentistry. Since 2013 she has worked in specialist practice in Exmouth at Fairfield House. In 2015 she became Consultant in Restorative Dentistry at Bristol NHS Foundation Trust, working there for 5 years as Lead for managing Dental Developmental Deformities and Abnormalities in the Southwest. She is actively involved in regional training/teaching for training Consultants and Postgraduates. She moved to Plymouth in 2020 to restart the Restorative department at University Hospitals Plymouth and is now Clinical Lead for Restorative Dentistry. She has worked for NHS England as the Southwest managed clinical network chair for Restorative Dentistry representing all restorative departments in the Southwest. She works with RD-UK a national society for Restorative Consultants as the MCN CEN chair. She has been offered the role of Deputy Chief dental officer for the Southwest and has been working in this role since June 2025 while waiting for its official start in 2026.

She is an active member on national dental committees supported by the Royal College of Surgeons of which she is a member. She is a member of the multi-disciplinary teams for; cleft, orthodontics, paediatrics, Head and Neck cancer and trauma. She has a variety of interests within the restorative field encompassing: dental implants, bespoke dentures, traumatic dental injury, and gum disease management. She helps to provide plans for patient's dental management that can be provided by general dental practitioners.

Since 2015 she has been on the medical board for the Society of Ectodermal Dysplasia and from 2024 she supports the Royal Osteoporosis Society as part of their College of Experts.



## Ashley Byrne

Ashley is the owner of Byrnes Dental Laboratory, a leader in modern dental technology. He qualified with a degree in Dental Technology in 2000 and started his own lab with his Dad in 2006. As early pioneers in the world of scanning and CAD-CAM, the lab has gone from strength to strength and now even has its own training facility.

Ashley lectures on digital dentistry, and building a highly motivated team, and has spoken in countries as far as the USA, India and South Africa. Their training facility is one of the first of its kind, working to take school leavers through their technical education and to become world leading dental technicians.

In his spare time Ashley is a keen cook and has a smallholding for chickens and goats.



### **Cristian Peron**

Dr. Cristian Peron has completed his DDS degree at the University of Turin, Italy, 2002; he has a Master Degree in Periodontology and in Oral Implantology at the University of Milan, has completed a two years of Advanced Course in Clinical Periodontology University of Berne School of Dental Medicine. In 2015 he has completed an International Achievement in Implantology and Oral Rehabilitation NYU University and becoming tutor of the Italian Association of the NYU University. He has published several articles and scientific posters in national and international journals; is a Lecturer in National and International Conferences and Courses; is a Dentist in Private Practice specialized in Periodontics and Implant Dentistry in Turin, Italy.



### **Raj Rattan MBE**

Raj Rattan is a general dental practitioner who owned and operated a small group practice for over 30 years, building a diverse portfolio career alongside his clinical work.

He became involved in postgraduate education initially as a Programme Director and later as Strategic Associate Dean for Foundation Training in London. He has provided consultancy services to both public and private sector organisations, including the NHS, Denplan, dental corporates, and the Department of Health, where he previously served as a Policy Adviser.

Raj is the author and co-author of several textbooks and numerous articles, and he has lectured extensively across the UK and internationally.

He worked as a part-time dento-legal consultant at Dental Protection for more than 20 years before taking up the role of Dental Director in 2016. He has recently been appointed Global Adviser to the Medical Protection Society, where he created and developed the Safer Practice Framework for the adoption and integration of artificial intelligence into clinical practice.

Outside dentistry, his interests include writing fiction, philosophy, motor sport, and magic. He is a member of The Magic Circle and was awarded the Hoffman Prize in 2011 for his work on exposure.



### **Shakeel Shahdad**

Shakeel Shahdad is a Consultant and Honorary Clinical Professor in Oral Rehabilitation & Implantology at The Royal London Dental Hospital, and Barts & The London School of Medicine and Dentistry at Queen Mary University of London.

He is the Clinical Lead for Restorative Dentistry, Lead for postgraduate implant training and Chairman of ITI Scholarship Centre at QMUL.

He is a specialist in Restorative Dentistry, Periodontics, Prosthodontics and Endodontics. In 2017, he was conferred Fellowship of the Faculty of Dental Trainers (FFDTEd) by The Royal College of Surgeons of Edinburgh.

He is a Fellow of the International Team for Implantology. He is also the Past Chairman of the Advisory Board in Implant Dentistry for the Royal College of Surgeons of Edinburgh and the ITI UK & Ireland Section. He is an examiner for the Royal College of Surgeons of Edinburgh and examines for speciality examinations in Restorative Dentistry, Prosthodontics, Periodontology, and Membership in Implant Dentistry Exam.

Apart from the specialist restorative treatment, his areas of particular interest include aesthetic implant dentistry, digital workflow, and management of complex restorative cases including functional and aesthetic rehabilitation of patients with hypodontia and toothwear. Shakeel specialises in treating patients requiring complex and advanced restorative treatment including surgical placement and restoration with dental implants.

He is active in clinical research and has secured over £3m research grants. He is a co-author of a textbook in periodontology and implant dentistry, besides publishing in peer-reviewed journals.

He also runs a multi-specialist referral practice in the West End of London

### **Dr Shalini Kanagasingam**

Shalini commenced specialist training at King's College London in 2006 obtaining the MClintDent in Endodontology with Distinction and Membership in Restorative Dentistry of the Royal College of Surgeons of Edinburgh in 2009. She is the Endodontic Lead for the BDS and BDSi programmes at the School of Medicine & Dentistry, University of Lancashire. She is a Course Lead for the MSc and DClinDent Endodontology programmes. She is currently an Honorary Consultant at the UHMB NHS Trust, Royal Lancaster Infirmary. She provides private specialist endodontic treatment at Camden Place Dental Practice & Implant Centre in Preston.

Shalini was recently elected as the British Endodontic Society (BES) Communications Officer, MFDS Part 2 Preparation Course Convenor and Dental Education Board member of RCPSGlasgow, Endodontics Examination Board Member for the Tri-collegiate Dental Specialty Fellowship Examinations (DSFE), School Ethics & CPD Lead, a member of the European Society of Endodontology Clinical Practice Committee and Deputy Chair of the DentsplySirona Peers Endodontic Board. She is the Chairperson of the British Dental Association Ribble Section, actively organising CPD programmes for the dental team in the Northwest.

Shalini has published over 40 scientific articles and contributed to dental textbooks including the 'Principles of Endodontics', 'CBCT in Endodontics' and 'Pitt Ford's Problem-Based Learning in Endodontology'. Shalini was awarded the ODRT OHI (PREVISER) AWARD in 2018 and the TCWhite Young Researcher's Grant in 2019 to support her research on oral biofilm and Alzheimer's Disease. In 2025, she was awarded 2 Pump Priming Grants from the Royal College of Surgeons England. She is a recipient of the BES Inspirational Full Time Lecturer Award.

### **Professor Nikos Donos**

Professor Nikos Donos is the Director of Research, Professor & Chair of Periodontology and Implant Dentistry, at the Centre for Oral Clinical Research (COCR), Institute of Dentistry, Queen Mary University of London (QMUL).

In 2024, Prof. Donos was awarded the prestigious International Association for Dental Research (IADR) Distinguished Scientist in Periodontal Disease Award, the European Federation of Periodontology (EFP) Distinguished Scientist Award and the FDS RCSEd ad Hominem. In 2011, he was presented with the IADR- Periodontology Group award in Periodontal Regenerative Medicine and in 2019 the American Academy of Periodontology (AAP) Clinical Research Award for his contribution as co-author. In 2004, Professor Donos was awarded the European Association of Osseointegration (EAO)- Basic Science Research Award.

In 2009, Prof. Donos has been presented with the title of Honorary Professor at the Faculty of Dentistry in Hong Kong, in 2012 the title of Adjunct Professor at the Dental School-Griffith University in Australia, in 2015 the title of Honorary Professor at UCL-Eastman Dental Institute and in 2019 the title of Honorary Professor, School of Dentistry, University of Queensland, Australia.

Professor Donos is Past President of the British Society of Periodontology & Implant Dentistry (BSP) (2020), the Past Academic Representative of the Committee of the Association of Dental Implantology (ADI)(UK) and is a board member of the Osteology Foundation (OF)-Switzerland where he also is the Chair of the Science Committee (for OF). Furthermore, Professor Donos is the Lead of the European Federation of Periodontology (EFP) Education Committee (PEC).

Prof. Donos is the Editor in Chief for Journal of Clinical Periodontology, the Associate Editor for Periodontology 2000, a topic editor (2022) for Frontiers in Bioengineering and Biotechnology and is/ has been involved as editorial board member in international peer-reviewed journals in the field of Periodontology and Implant Dentistry.

Prof. Donos has published more than 290 peer reviewed publications, is the editor of 5 textbooks and author/co-author of 15 book chapters in the field of Periodontology and Implant Dentistry.

Prof Donos has significant clinical experience in providing advanced treatment modalities to patients suffering from severe periodontal disease.
